Coronavirus & Redevelopment

Hardly a day goes by where someone doesn't ask, "So, how is the coronavirus situation impacting CRHA's redevelopment efforts?" While our standard answer over the past month or so has typically some version of, "Well, let's wait and see," we are starting now to get a clearer idea of what lies ahead.

- Crescent Halls: The Crescent Halls renovation project is still happening, but for now it is on hold. Since the apartments at Crescent Halls will be renovated while the building is still occupied, we simply cannot have moving crews, construction crews, etc. coming in and out of the building right now and potentially exposing our residents to the virus. Seniors and individuals with disabilities face the highest threat from the virus, and we will not put their health at risk. Our General Contractor, Cornelius Griggs, is monitoring this situation closely, and once he and our development team are confident that the threat from the virus has lowered to where construction can safely begin, we will inform residents accordingly. Crescent Halls residents helped us to choose a moving company (Milo the Mover) to start relocating people once the relocation process begins, but we do not expect the renovation work to start until much later in 2020 at the earliest. Stay tuned for more info.
- South First St. Phase One: Construction of 62 new affordable apartments and a community center on the ballfield at South First St. is moving forward and will hopefully be underway this summer.
- South First St. Phase Two: We are currently awaiting the results of our application for Low Income Housing Tax Credit (LIHTC) funding for the construction of 113 new affordable townhouses & apartments to replace the existing 58 units at South First St. If the funding comes through for this project, we expect construction to get underway sometime in spring or summer of 2021.
